

London Borough of Redbridge - Talent Development Programme Application

Terms and Conditions

1. London Borough of Redbridge - Talent Development Programme applications are open to performers aged 14 years old and above. Performers must be UK citizens/UK residents/have indefinite leave to remain and/or be eligible to work in the UK
2. If you are 17 years old or under, London Borough of Redbridge shall require prior written consent from a parent/legal guardian / authorised organisation to obtain the right to apply and, if selected, perform.
3. If you are selected to perform and are aged 14–15 years old, London Borough of Redbridge require a parent/legal guardian / authorised organisation to chaperone your performance.
4. If you are selected to perform and are aged 16-17 years old, London Borough of Redbridge require a parent/legal guardian / authorised organisation to give prior written consent for you to perform without a chaperone.
5. All entries for the Inllford Jubilee event must be received by 1700 on Monday 23 May 2022. All entries for the Talent Development scheme must be received by 1700 on Friday 1 July. Applications received after this will not be considered.
6. All instruments/equipment necessary for the performance must be provided by you and must be portable and carried by hand. All equipment requiring power must run from dry batteries. The performer shall not use any hazardous or obstructive equipment.
7. You must provide a link to a video sharing website. These clips may already exist on any video sharing sites e.g YouTube or Vimeo. Uploaded video clips must be a maximum length of 5min, representative of your intended performance should you be selected and contain all members of your act. All performers in your video clip must consent to being filmed. London Borough of Redbridge may require proof of this consent. The material must not include any sexual content or reference, violence or bad language. Material containing scenes of a graphic or offensive nature will be disqualified immediately.
8. By applying to London Borough of Redbridge –Talent Development Programme, you agree to participate in such promotional activity and material as London Borough of Redbridge, Busk in London and affiliated partners may require. London Borough of Redbridge, Busk in London and affiliated partners have unlimited rights to broadcast and record, videotape, televise, film and photograph London Borough of Redbridge events, to make audio or visual recordings of them and to broadcast them on the internet, television and radio and other information networks without payment to the performers for non-profit making activities for a maximum of five (5) years after a successful

application. After this period, performers have the full right to request that videos are no longer used. London Borough of Redbridge and Busk in London also reserves the right to publish information about the performers disclosed in their application in press/media work and on both the London Borough of Redbridge website and the Busk in London website.

9. The decisions of the assessment panel will be final at all stages. No correspondence or discussion will be entered into.
10. Acceptance onto the London Borough of Redbridge Talent Development Programme does not give you a right to perform or busk in London Borough of Redbridge except when and where authorised in conjunction with this programme.
11. London Borough of Redbridge and Busk in London reserve the right to invite applications
12. London Borough of Redbridge /Busk in London reserve the right to amend these Terms and Conditions at any time and without prior notification or communication.
